This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. The accompanying Statement includes unaudited interim financial results and other unaudited financial information in respect of 3 subsidiaries, whose interim financial results and other financial information reflect total assets of Rs. 2,331.86 lacs as at 30th June, 2026 and total revenues of Rs 5.42 lacs, total net loss after tax Rs 9.17 lacs for the quarter ended 30th June, 2026 and period ended on that date respectively.

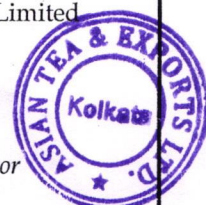
