I, **CS PUJA PUJARI**, Proprietor of Puja Pujari & Associates, Practicing Company Secretary, was appointed as the Scrutinizer by the Board of Directors of **ASIAN TEA & EXPORTS LIMITED** ("the Company") vide appointment letter dated 26th March, 2026, for the purpose of scrutinizing the Postal Ballot process conducted through remote e-voting in a fair and transparent manner.

1. The Company had provided remote e-voting facility offered by NSDL to its shareholders.
2. The remote e-voting period remained open from **Sunday, 05th April, 2026 at 9.00 a.m. (IST) to Monday, 04th May, 2026 at 5.00 p.m. (IST).**
3. The members of the Company as on the "cut-off" date i.e. 27th March, 2026 were entitled to vote on the resolutions as set out in the Notice of Postal Ballot.
4. The votes cast through remote e-voting were unblocked on 04th May, 2026 at 7:38 p.m. in the presence of two witnesses namely Ms. Manisha Saboo and Ms. Shiwani Dubey who are not in the employment of the Company.
5. Thereafter, the details containing inter-alia, list of members, who voted "For" or "Against" on each of the resolutions that were put to vote, were derived from the report generated from the e-voting website of the NSDL, www.evoting.nsdl.com.
